All LL.M. students of Semester IV pursuing LL.M. (General) Course and LL.M. (H.R. & V.E.) Course, Session 2023-24 are hereby informed that regarding the "Dissertation Paper" in LL.M. Part-II following instructions and guidelines have to be complied with:

GENERAL INSTRUCTIONS:

- Assistant Professors as Dissertation Supervisors can supervise a maximum of **Five (05)** LL.M. Students at a given time in the final semester.
- Associate Professors as Dissertation Supervisors can supervise a maximum of **Seven (07)** LL.M. Students at a given time in the final semester.
- After the above allotment is exhausted, the Head, Department of Law will make amicable allotment of remaining odd number of candidates (if any) as per the seniority of Faculty Members or any other arrangement as per need.
- Each supervisor shall take Minimum Two (02) students pursuing LL.M. (H.R. & V.E.) Course under him/her. Rest of the students may be taken by the Supervisor in any Specialization Clusters of LL.M. (General) Course with a maximum cap of "two (02) students" in any one (01) of the specialization cluster i.e.
One Assistant Professor: Total 05 Dissertations [02 LL.M. H.R. & V.E. + 02 LL.M. General (Specialization Cluster) (Any One Branch) + 01 Any other LL.M. General (Specialization Cluster)]
One Associate Professor: Total 07 Dissertations [02 LL.M. H.R. & V.E. + 02 LL.M. General (Specialization Cluster) (Any One Branch) + 02 LL.M. General (Specialization Cluster) (Any One Branch) + 01 Any Other LL.M. General (Specialization Clusters Available)]
- The students are directed to fill in the required details in the "**Dissertation allotment and Approval Form by Supervisor**" attached with this Office-Order.
- After filling in the details, the willing students may approach their choice of Supervisor from the List of Supervisor's (Permanent Faculty) attached with this Office-Order with a choice of topic which shall relate strictly to the same specialization cluster in which they are pursuing their course. The same topic may be discussed with the supervisor and the



final topic of the Dissertation for any candidate shall be allotted and approved by the written consent of the Supervisor and duly verified by Head, Department of Law.


- Once approved by the Supervisor, the same filled in "Dissertation allotment and Approval Form by Supervisor" duly signed shall be deposited in the Office of the Undersigned and only after successful submission of the same and after verification by HOD, the topic will be finalized for the candidate.
- The last date for submission of the filled in duly signed "Dissertation allotment and Approval Form by Supervisor", in the Office of the Undersigned is **27th February, 2024 (Tuesday)**.
- On **01st March, 2024** the department will publish the final and consolidated list of Supervisor's / Candidates / Topics Allotted.
- The dissertation should be of minimum **90 (ninety)** pages in total, shall be hard bound and top cover page shall be **SKY BLUE** with **BLACK** embossing of letters. The dissertation shall be printed on both sides of the page.
- The entire research work shall conform to the standard Indian Law Institute (ILI) footnoting style as updated from time to time available at: <https://ili.ac.in/cstyle.pdf> and at <https://ili.ac.in/footnoting12.pdf>
- All Supervisor's shall ensure that the dissertation submitted by the candidate qualifies the research ethics and is made as per the common format provided.
- **All students shall ensure from the Office of the Department of Law that their proposed dissertation topics shall not have been already researched upon in the Department of Law by any other former student in the last two (02) years. If violating this instruction any student will submit his/her application in the Department, the same shall be rejected by the undersigned.**
- It is suggested that the students should be in touch with their supervisors throughout the completion of their research work and responsibility for any delay in final submission of the dissertation shall rest solely with the candidate only.
- **Four (04) Copies of Dissertation shall be submitted by the candidate to the Department of Law on or before 29th April, 2024 (Monday) thereafter which no submission will be permitted. (1 Copy for Supervisor, 3 Copies for External Examiners).**

GUIDELINES RELATING TO DISSERTATION:

- a. The Department will circulate Two (02) common word formats named "Cover Page" and "Associated Pages & Final Document" in due course for making the dissertation.
- b. All the titles of the individual chapters shall establish a link with the main title of the research work

- c. All chapters shall have an 'introduction' and a 'conclusion' describing the work to be done by the candidate in that very chapter and before closing of the individual chapter summarize the chapter in few lines giving a hint as to what will be researched by the candidate in the coming chapter
- d. Similarly in the next chapter candidate shall mention as to what he/she did in the last chapter and what is to be proposed and attempted in this chapter
- e. The page numbers in this second document (associated pages) shall be in roman numbers and when the candidate starts writing the third document i.e. The dissertation starting from chapter one the page numbers shall start with 01, 02 and so on.
- f. The entire proposed research work should be in 1.5 spacing, times new roman 12 format justified with page borders and footer as provided in the document mentioned in Point a.
- g. For any clarifications on above, students may contact their respective supervisor's.
